A BILL FOR AN ACT

101 **CONCERNING SUPPORT FOR EXPANDING BROADBAND ACCESS FOR**
102 **PRESCHOOL THROUGH TWELFTH GRADE EDUCATION, AND, IN**
103 **CONNECTION THEREWITH, CREATING THE CONNECTING**
104 **COLORADO STUDENTS GRANT PROGRAM AND MAKING AN**
105 **APPROPRIATION.**

providing broadband service and other technology for increased internet access for students, educators, and other staff. The program is created in the department of education (department). The department reviews applications and the commissioner of education (commissioner) awards the grants. The department must consult with the office of information technology, the office of economic development, and broadband and education technology experts in reviewing the applications.

The bill specifies the required contents of grant applications, the criteria that the department and the commissioner must consider in reviewing and awarding grants, and criteria for prioritizing applicants. The bill creates the connecting Colorado students grant program fund out of which grants are paid. By February 1, 2021, the department must distribute the money appropriated to the department for the 2020-21 budget year for grants.

Beginning in July 2021, the department must submit to the state board of education, governor, and education committees of the general assembly a report concerning implementation of the program.

By January 10, 2021, the department, in collaboration with the office of information technology and broadband service providers, must develop and make publicly available a list of free or low-cost broadband services and other internet access resources.

6 **22-103-101. Legislative declaration.** (1) THE GENERAL
7 ASSEMBLY FINDS THAT:

8 (a) THE COVID-19 PANDEMIC HAS LED MANY SCHOOL DISTRICTS
9 AND PUBLIC SCHOOLS DURING THE 2019-20 AND 2020-21 SCHOOL YEARS
10 TO MOVE BETWEEN PERIODS OF ONLINE INSTRUCTION, IN-PERSON
11 INSTRUCTION, AND A HYBRID OF ONLINE AND IN-PERSON INSTRUCTION;

12 (b) TO LEARN ONLINE, A STUDENT MUST HAVE ACCESS TO
13 ADEQUATE BROADBAND SERVICE THAT ALLOWS FOR ONLINE INSTRUCTION,

1 INCLUDING VIDEO CONFERENCING, TAKING INTO ACCOUNT THE ACCESS
2 NEEDS OF OTHER INTERNET USERS WITHIN THE STUDENT'S HOUSEHOLD;

3 (c) STUDENTS FROM LOW-INCOME BACKGROUNDS, STUDENTS
4 EXPERIENCING HOMELESSNESS, MIGRANT STUDENTS, STUDENTS FROM
5 RURAL COLORADO, AND STUDENTS IN FOSTER CARE ARE LESS LIKELY TO
6 HAVE ACCESS TO HIGH-SPEED BROADBAND SERVICE;

7 (d) A REPORT DEVELOPED BY THE COLORADO DEPARTMENT OF
8 EDUCATION AND THE COLORADO EDUCATION INITIATIVE AND RELEASED
9 IN APRIL 2020 FOUND THAT ALMOST SIXTY-SIX THOUSAND PUBLIC SCHOOL
10 STUDENTS IN COLORADO LACK ANY INTERNET ACCESS;

11 (e) WITHOUT ADEQUATE INTERNET ACCESS, STUDENTS ARE LESS
12 LIKELY TO BE ABLE TO PARTICIPATE IN CLASS, MORE LIKELY TO
13 EXPERIENCE SIGNIFICANT LEARNING LOSS, AND MORE LIKELY TO FALL
14 BEHIND THEIR PEERS WHO HAVE ACCESS TO HIGH-SPEED INTERNET;

15 (f) EDUCATION EXPERTS ESTIMATE THAT, WHILE THE AVERAGE
16 ELEMENTARY AND SECONDARY STUDENT IS LIKELY TO LOSE SEVEN
17 MONTHS OF LEARNING AS A RESULT OF THE COVID-19 PANDEMIC, THE
18 LEARNING LOSS IS SIGNIFICANTLY GREATER FOR STUDENTS OF COLOR AND
19 LOW-INCOME STUDENTS: HISPANIC STUDENTS MAY FALL BEHIND BY MORE
20 THAN NINE MONTHS, BLACK STUDENTS BY MORE THAN TEN MONTHS, AND
21 LOW-INCOME STUDENTS BY MORE THAN A YEAR;

22 (g) THE COVID-19 PANDEMIC HAS HAD A SIGNIFICANT IMPACT ON
23 THE MENTAL HEALTH AND WELL-BEING OF STUDENTS, EDUCATORS, AND
24 OTHER STAFF, AND TELEHEALTH SERVICES, COMBINED WITH ADEQUATE
25 BROADBAND SERVICE, CAN HELP INDIVIDUALS ACCESS BEHAVIORAL
26 HEALTH SERVICES IN THEIR HOMES;

27 (h) IN ADDITION TO STUDENTS, MANY EDUCATORS AND OTHER

1 STAFF LACK ADEQUATE BROADBAND SERVICE TO PROVIDE ONLINE
2 INSTRUCTION;

3 (i) BROADBAND SERVICE PROVIDERS ACROSS THE STATE HAVE
4 PROVIDED LOW- AND NO-COST OPTIONS FOR LOCAL EDUCATION PROVIDERS
5 AND FAMILIES TO HELP GET STUDENTS THE ABILITY TO PARTICIPATE IN
6 ONLINE INSTRUCTION;

7 (j) MANY LOCAL EDUCATION PROVIDERS ARE WORKING
8 COLLABORATIVELY WITH BROADBAND SERVICE PROVIDERS TO DEVELOP
9 INNOVATIVE SOLUTIONS TO ADDRESS INTERNET ACCESS AND CAPACITY,
10 PARTICULARLY IN RURAL COMMUNITIES; AND

11 (k) ADDITIONAL RESOURCES ARE NECESSARY TO ENSURE THAT
12 EVERY COLORADO STUDENT HAS ACCESS TO THE HIGH-SPEED BROADBAND
13 SERVICE NECESSARY FOR ONLINE INSTRUCTION.

14 (2) THE GENERAL ASSEMBLY FINDS, THEREFORE, THAT IT IS
15 CRITICAL TO QUICKLY PROVIDE RESOURCES FOR LOCAL EDUCATION
16 PROVIDERS TO USE IN GIVING STUDENTS, EDUCATORS, AND OTHER STAFF
17 INCREASED ACCESS TO BROADBAND SERVICE SO THAT STUDENTS MAY
18 BENEFIT FROM ONLINE INSTRUCTION AND SUCCESSFULLY LEARN ONLINE,
19 THEREBY PREVENTING LEARNING LOSS PARTICULARLY FOR LOW-INCOME
20 AND OTHER ACADEMICALLY AT-RISK STUDENTS.

13 WIRELESS FIDELITY, OR WI-FI, ANTENNAS; MOBILE HOTSPOTS; SATELLITE
14 CONNECTIONS; OR OTHER TECHNOLOGIES CAPABLE OF DELIVERING

16 (b) ADDRESSING BROADBAND INFRASTRUCTURE NEEDS IN

19 (2) TO OBTAIN A GRANT, A LOCAL EDUCATION PROVIDER MUST
20 SUBMIT A GRANT APPLICATION TO THE DEPARTMENT. EACH APPLICATION

22 (a) A DESCRIPTION OF HOW THE LOCAL EDUCATION PROVIDER HAS
23 CONSULTED WITH EDUCATORS AND OTHER SCHOOL-LEVEL AND
24 ADMINISTRATIVE STAFF AND WITH BROADBAND SERVICE PROVIDERS IN
25 PREPARING THE APPLICATION;

26 (b) A DESCRIPTION OF THE PROGRAMS, INCLUDING ANY FREE
27 RESOURCES, THAT THE LOCAL EDUCATION PROVIDER HAS PREVIOUSLY

1 ACCESSED TO PROVIDE INTERNET ACCESS FOR STUDENTS, EDUCATORS,
2 AND OTHER STAFF;

3 (c) A DESCRIPTION OF THE BROADBAND SERVICE THAT THE LOCAL
4 EDUCATION PROVIDER MAKES AVAILABLE TO STUDENTS, EDUCATORS, AND
5 OTHER STAFF AT THE TIME OF APPLICATION, INCLUDING THE USE OF FREE
6 RESOURCES;

7 (d) A DESCRIPTION OF THE INTERNET ACCESS NEEDS OF STUDENTS,
8 EDUCATORS, AND OTHER STAFF THAT ARE NECESSARY TO ENABLE
9 EFFECTIVE ONLINE TEACHING AND LEARNING AND THAT THE LOCAL
10 EDUCATION PROVIDER IS UNABLE TO MEET AT THE TIME OF APPLICATION;

11 (e) THE LOCAL EDUCATION PROVIDER'S PROPOSED PLAN TO MEET
12 THE INTERNET ACCESS NEEDS OF STUDENTS, EDUCATORS, AND OTHER
13 STAFF, INCLUDING WHETHER THE LOCAL EDUCATION PROVIDER IS SEEKING
14 TO IMPROVE INTERNET ACCESS AS PROVIDED IN SUBSECTION (1)(a) OF THIS
15 SECTION OR ADDRESSING BROADBAND INFRASTRUCTURE NEEDS AS
16 PROVIDED IN SUBSECTION (1)(b) OF THIS SECTION AND WHETHER THE
17 LOCAL EDUCATION PROVIDER IS PARTNERING OR PLANNING TO PARTNER

26 LOCAL EDUCATION PROVIDER REQUIRES TO PROVIDE SUFFICIENT INTERNET
27 ACCESS FOR STUDENTS, EDUCATORS, AND OTHER STAFF TO ENABLE

1 EFFECTIVE ONLINE TEACHING AND LEARNING;

2 (h) THE NUMBER AND OVERALL PERCENTAGES OF STUDENTS,
3 EDUCATORS, AND OTHER STAFF IN THE LOCAL EDUCATION PROVIDER'S
4 COMMUNITY OF STUDENTS, EDUCATORS, AND STAFF WHO WILL RECEIVE
5 IMPROVED INTERNET ACCESS AS A RESULT OF THE PROPOSED USE OF A
6 GRANT;

7 (i) THE BANDWIDTH SPEED OF THE BROADBAND SERVICE AND OF
8 THE INTERNET-ACCESS DEVICES, IF ANY, THAT WILL BE AVAILABLE TO
9 STUDENTS, EDUCATORS, AND OTHER STAFF AS A RESULT OF THE GRANT,
10 INCLUDING THE UPLOAD AND DOWNLOAD SPEEDS AND SUPPORT FOR WHY
11 THE IDENTIFIED SPEEDS ARE ADEQUATE FOR ONLINE LEARNING FOR EVERY
12 SCHOOL-AGED CHILD IN A HOUSEHOLD AND FOR EDUCATORS OR OTHER

16 (3) THE DEPARTMENT SHALL REVIEW THE APPLICATIONS RECEIVED
17 PURSUANT TO THIS SECTION AND RECOMMEND APPLICANTS AND GRANT
18 AMOUNTS TO THE COMMISSIONER. SUBJECT TO AVAILABLE
19 APPROPRIATIONS, THE COMMISSIONER SHALL AWARD THE GRANTS AND
20 DETERMINE THE AMOUNT OF EACH GRANT. THE DEPARTMENT SHALL
21 CONSULT WITH THE OFFICE OF INFORMATION TECHNOLOGY CREATED IN
22 SECTION 24-37.5-103, THE COLORADO OFFICE OF ECONOMIC

9 ADVANTAGE OF LOW- OR NO-COST OPTIONS FOR PROVIDING INTERNET
10 ACCESS TO STUDENTS, EDUCATORS, AND OTHER STAFF BEFORE SEEKING A
11 GRANT;

12 (c) THE MANNER IN WHICH THE APPLYING LOCAL EDUCATION
13 PROVIDER PRIORITIZES STUDENTS WHO ARE MOST AT RISK OF LEARNING
14 LOSS WHEN EDUCATIONAL SERVICES ARE PROVIDED THROUGH THE
15 INTERNET, INCLUDING STUDENTS EXPERIENCING HOMELESSNESS,
16 STUDENTS IN FOSTER CARE, MIGRANT STUDENTS, STUDENTS WHO LACK
17 ACCESS TO BROADBAND SERVICE, AND HIGHLY MOBILE STUDENTS;

18 (d) IF THE APPLICANT IS A SCHOOL DISTRICT OR A BOARD OF
19 COOPERATIVE SERVICES, THE DEGREE TO WHICH THE APPLYING LOCAL
20 EDUCATION PROVIDER'S PROPOSED USE OF A GRANT REPRESENTS A
21 LONG-TERM, SUSTAINABLE IMPROVEMENT IN THE LEVEL OF INTERNET
22 ACCESS AVAILABLE TO ALL OF THE SCHOOLS WITHIN THE APPLYING
23 SCHOOL DISTRICT OR WITHIN ALL OF THE SCHOOL DISTRICTS THAT ARE
24 MEMBERS OF OR PURCHASE SERVICES FROM THE APPLYING BOARD OF
25 COOPERATIVE SERVICES; AND

26 (e) THE DEGREE TO WHICH THE APPLYING LOCAL EDUCATION
27 PROVIDER HAS ACCESS TO OTHER FINANCIAL RESOURCES TO USE IN

1 PROVIDING INTERNET ACCESS TO STUDENTS, EDUCATORS, AND OTHER
2 STAFF.

3 (4) IN RECOMMENDING AND AWARDED GRANTS, THE DEPARTMENT
4 AND THE COMMISSIONER SHALL PRIORITIZE:

5 (a) LOCAL EDUCATION PROVIDERS THAT, FOR THE 2019-20 SCHOOL
6 YEAR, SERVED A STUDENT POPULATION THAT INCLUDED A HIGH
7 PERCENTAGE OF STUDENTS WHO WERE ELIGIBLE FOR FREE OR
8 REDUCED-PRICE MEALS UNDER THE FEDERAL "RICHARD B. RUSSELL
9 NATIONAL SCHOOL LUNCH ACT", 42 U.S.C. SEC. 1751 ET SEQ.; AND

10 (b) LOCAL EDUCATION PROVIDERS THAT SERVE A STUDENT
11 POPULATION THAT INCLUDES A HIGH PERCENTAGE OF STUDENTS WITH
12 LITTLE OR NO ACCESS TO BROADBAND SERVICE, AS DETERMINED USING
13 BROADBAND SERVICE SUBSCRIPTION PERCENTAGE ESTIMATES AVAILABLE
14 FROM THE UNITED STATES CENSUS BUREAU'S AMERICAN COMMUNITY
15 SURVEY.

16 (5) BY FEBRUARY 1, 2021, THE DEPARTMENT SHALL DISTRIBUTE
17 AS GRANTS TO LOCAL EDUCATION PROVIDERS THE ENTIRE AMOUNT
18 APPROPRIATED TO THE FUND FOR THE 2020-21 BUDGET YEAR, LESS THE
19 AMOUNT ALLOWED FOR EXPENSES.

20 **22-103-104. Report.** (1) ON OR BEFORE JULY 15, 2021, THE
21 DEPARTMENT SHALL SUBMIT A REPORT TO THE STATE BOARD OF
22 EDUCATION, GOVERNOR, AND EDUCATION COMMITTEES OF THE SENATE
23 AND HOUSE OF REPRESENTATIVES, OR ANY SUCCESSOR COMMITTEES,
24 CONCERNING IMPLEMENTATION OF THE PROGRAM. AFTER THE INITIAL
25 REPORT, THE DEPARTMENT SHALL SUBMIT A REPORT TO THE SAME PARTIES
26 WITHIN SIX MONTHS AFTER THE END OF A BUDGET YEAR IN WHICH THE

2 (a) THE NUMBER OF LOCAL EDUCATION PROVIDERS THAT APPLIED

4 RECEIVED A GRANT;

5 (b) THE NUMBER OF STUDENTS AND THE NUMBER OF EDUCATORS
6 AND OTHER STAFF WHO RECEIVED IMPROVED INTERNET ACCESS AS A
7 RESULT OF THE USE OF GRANTS;

8 (c) A DESCRIPTION OF THE USE OF THE GRANTS IN PROVIDING
9 BROADBAND SERVICE AND IMPROVED INTERNET ACCESS;

10 (d) A DESCRIPTION OF INNOVATIVE PROGRAMS THAT OTHER LOCAL

24 **22-103-105. Broadband service resources for local education**
25 **providers - public list.** THE DEPARTMENT, IN COLLABORATION WITH THE
26 OFFICE OF INFORMATION TECHNOLOGY CREATED IN SECTION 24-37.5-103
27 AND BROADBAND SERVICE PROVIDERS, SHALL DEVELOP AND UPDATE AS

1 NECESSARY A LIST OF FREE OR LOW-COST BROADBAND SERVICES AND
2 OTHER INTERNET ACCESS RESOURCES FOR STUDENTS, EDUCATORS, AND

8 **fund - created - legislative declaration.** (1) (a) THE CONNECTING
9 COLORADO STUDENTS GRANT PROGRAM FUND IS HEREBY CREATED IN THE
10 STATE TREASURY. THE FUND CONSISTS OF MONEY CREDITED TO THE FUND
11 PURSUANT TO SUBSECTION (2) OF THIS SECTION AND ANY OTHER MONEY
12 THAT THE GENERAL ASSEMBLY MAY APPROPRIATE OR TRANSFER TO THE
13 FUND. THE STATE TREASURER SHALL CREDIT ALL INTEREST AND INCOME

1 TREASURER, WHO SHALL CREDIT THE MONEY TO THE FUND.

2 (3) THE GENERAL ASSEMBLY DECLARES THAT, FOR PURPOSES OF
3 SECTION 17 OF ARTICLE IX OF THE STATE CONSTITUTION, THE PROGRAM
4 IS AN IMPORTANT ELEMENT IN IMPROVING STUDENT SAFETY AND MAY
5 THEREFORE RECEIVE FUNDING FROM THE STATE EDUCATION FUND
6 CREATED IN SECTION 17 (4) OF ARTICLE IX OF THE STATE CONSTITUTION.

7 **22-103-107. Repeal of article. THIS ARTICLE 103 IS REPEALED,**
8 **EFFECTIVE FEBRUARY 1, 2022.**

9 **SECTION 2. Appropriation.** For the 2020-21state fiscal year,
10 \$20,000,000 is appropriated to the connecting Colorado students grant
11 program fund created in section 22-103-106, C.R.S., for use by the
12 department of education. This appropriation is from the general fund. To
13 implement this act, the department may use this appropriation to
14 implement the connecting Colorado students grant program created in
15 article 103 of title 22, C.R.S.

16 **SECTION 3. Safety clause.** The general assembly hereby finds,
17 determines, and declares that this act is necessary for the immediate
18 preservation of the public peace, health, or safety.
