(commissioner) to appoint 2 members to the workers' compensation classification appeals board who are salaried employees of an insurance company that issues workers' compensation insurance policies in this state or who are representatives of Pinnacol Assurance. The bill gives the commissioner the additional option to appoint insurance agents to these 2 seats and to appoint an insurance agent to serve as an alternate member if one of the appointed members recuses himself or herself. The bill continues the workers' compensation classification appeals board until 2032.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 8-55-101, **amend**
3 (1)(a) and (2) as follows:

4 **8-55-101. Workers' compensation classification appeals board**
5 **- creation.** (1) There is hereby created, in the division of insurance in the
6 department of regulatory agencies, the workers' compensation
7 classification appeals board. The board shall hear grievances brought by
8 employers against insurers and Pinnacol Assurance concerning the
9 calculation of experience modification factors and classification
10 assignment decisions. The board shall consist of five voting members,
11 each of whom shall be knowledgeable about workers' compensation
12 classification and experience modification factors, and one nonvoting
13 member, as follows:

14 (a) (I) ~~Two members shall~~ ONE MEMBER MUST be either:

15 (A) A salaried ~~employees~~ EMPLOYEE of an insurance company
16 that issues workers' compensation insurance policies in this state; or

17 (B) ~~representatives~~ A REPRESENTATIVE of Pinnacol Assurance.

18 (II) ONE MEMBER MUST BE:

19 (A) A SALARIED EMPLOYEE OF AN INSURANCE COMPANY THAT
20 ISSUES WORKER'S COMPENSATION POLICIES IN THIS STATE;

1 (B) A REPRESENTATIVE OF PINNACOL ASSURANCE; OR

2 (C) AN INSURANCE AGENT LICENSED IN THIS STATE.

3 (III) ~~Such~~ THE two members ~~shall~~ APPOINTED PURSUANT TO
4 SUBSECTIONS (1)(a)(I) AND (1)(a)(II) MUST not both represent Pinnacol
5 Assurance or the same insurance company. In addition, one person ~~shall~~
6 MUST be selected to serve as an alternate member to represent the
7 interests of the insurance industry, ~~or~~ Pinnacol Assurance, OR INSURANCE
8 AGENTS. The alternate shall represent such interests ~~in the event~~ IF the
9 primary member recuses himself or herself.

10 (2) THE COMMISSIONER OF INSURANCE SHALL APPOINT the private
11 employer members and the members representing insurers, INSURANCE
12 AGENTS, and Pinnacol Assurance. ~~shall be appointed by the commissioner~~
13 ~~of insurance.~~ The workers' compensation rating organization
14 representative shall be appointed by the chief executive officer of such
15 organization or by another officer designated to make such appointment.
16 The commissioner may solicit a list of nominees from any interested party
17 before making such appointments. The commissioner shall immediately
18 notify the workers' compensation rating organization concerning the
19 identity of any appointees.

20 **SECTION 2.** In Colorado Revised Statutes, 8-55-105, **amend** (1)
21 as follows:

22 **8-55-105. Repeal of article.** (1) This ~~article~~ ARTICLE 55 is
23 repealed, effective ~~July 1, 2021~~ SEPTEMBER 1, 2032.

24 **SECTION 3.** In Colorado Revised Statutes, 24-34-104, **repeal**
25 (20)(a)(I); and **add** (33)(a)(II) as follows:

26 **24-34-104. General assembly review of regulatory agencies**
27 **and functions for repeal, continuation, or reestablishment - legislative**

1 **declaration - repeal.** (20) (a) The following agencies, functions, or both,
2 will repeal on July 1, 2021:

5 (33) (a) The following agencies, functions, or both, are scheduled
6 for repeal on September 1, 2032:

7 (II) THE WORKERS' COMPENSATION CLASSIFICATION APPEALS
8 BOARD CREATED IN ARTICLE 55 OF TITLE 8.

9 **SECTION 4. Safety clause.** The general assembly hereby finds,
10 determines, and declares that this act is necessary for the immediate
11 preservation of the public peace, health, or safety.
