# A BILL FOR AN ACT CONCERNING THE CREATION OF A SPECIAL OLYMPICS LICENSE PLATE FOR MOTOR VEHICLES, AND, IN CONNECTION THEREWITH,

### 103 MAKING AN APPROPRIATION.

## **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <a href="http://leg.colorado.gov">http://leg.colorado.gov</a>.)

The bill creates the Special Olympics license plate for motor vehicles. A person qualifies for issuance of the plate if the person makes a donation to a designated nonprofit organization. The designated nonprofit organization must:

• Be headquartered in Colorado;

- Have existed for at least 40 years;
- Provide year-round sports training and athletic competitions for children and adults with intellectual disabilities;
- Collaborate with schools throughout Colorado to bring students together through shared activities that include sports, leadership opportunities, and health education and fitness; and
- Ensure that the donation is spent in Colorado to support athletes with intellectual disabilities.

In addition to the normal fees for a license plate, a person must pay 2 additional one-time fees for the issuance of the plate. One of these fees is credited to the highway users tax fund and the other fee is credited to the licensing services cash fund.

3	when the plate was created, or SPECIAL license plates issued pursuant to
4	sections 42-3-211 to 42-3-214, sections 42-3-217 to 42-3-218, sections

6	shall pay an issuance fee of twenty-five dollars; except that the fee is not
7	imposed on special license plates exempted from additional fees for the
8	issuance of a military special license plate by section 42-3-213 (1)(b)(II).
9	The department shall transfer the fee to the state treasurer, who shall
10	credit it to the licensing services cash fund created in section 42-2-114.5.
11	<b>SECTION 3.</b> Appropriation. (1) For the 2021-22 state fiscal
12	year, \$13,460 is appropriated to the department of revenue for use by the
13	division of motor vehicles. This appropriation consists of \$5,400 from the
14	Colorado DRIVES vehicle services account in the highway users tax fund
15	created in section 42-1-211 (2)(b)(I), C.R.S., and \$8,060 from the license
16	plate cash fund created in section 42-3-301 (1)(b), C.R.S. To implement
17	this act, the division may use this appropriation as follows:
18	(a) \$5,400 from the Colorado DRIVES vehicle services account
19	in the highway users tax fund for DRIVES maintenance and support; and
20	(b) \$8,060 from the license plate cash fund for license plate
21	ordering.
22	SECTION 4. Act subject to petition - effective date. This act
23	takes effect at 12:01 a.m. on the day following the expiration of the
24	ninety-day period after final adjournment of the general assembly; except
25	that, if a referendum petition is filed pursuant to section 1 (3) of article V
26	of the state constitution against this act or an item, section, or part of this
27	act within such period, then the act, item, section, or part will not take
