1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Senate Bill 21-196, **amend** section 1 (1)
3 introductory portion and (1)(a) as follows:

4 Section 1. **Appropriation.** (1) For the 2021-22 state fiscal year,
5 ~~\$54,276,399~~ \$54,893,747 is appropriated to the legislative department.
6 This appropriation consists of ~~\$53,005,160~~ \$53,622,508 from the general
7 fund, \$90,000 from cash funds, and \$1,181,239 from reappropriated
8 funds. The legislative department may use this appropriation as follows:

9 (a) ~~\$18,206,852~~ \$18,824,200 for use by the general assembly,
10 which amount:

11 (I) Consists of ~~\$18,116,852~~ \$18,734,200 from the general fund
12 and \$90,000 from cash funds generated from the sale of bill boxes,
13 legislative directories, and publications and other services provided by the
14 print shop; and

15 (II) Is based on the assumption that the general assembly will have
16 ~~74.4~~ 144.4 FTE;

17 **SECTION 2. Effective date.** This act takes effect upon passage
18 only if Senate Bill 21-196 becomes law and takes effect either upon the
19 effective date of this act or Senate Bill 21-196, whichever is later.

20 **SECTION 3. Safety clause.** The general assembly hereby finds,
21 determines, and declares that this act is necessary for the immediate
22 preservation of the public peace, health, or safety.
