**A BILL FOR AN ACT**

101 **CONCERNING CHANGES TO THE DOMESTIC VIOLENCE FATALITY**  
102 **REVIEW BOARD STATUTES.**

---

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill requires the domestic violence fatality review board (review board) to:

- Provide technical assistance and training to local governments to help establish and maintain a review team and provide technical assistance and training to existing review teams;

Shading denotes HOUSE amendment. Double underlining denotes SENATE amendment.  
Capital letters or bold & italic numbers indicate new material to be added to existing statute.  
Dashes through the words indicate deletions from existing statute.

- Pursue and implement any recommendations received in the previous year;
- Provide any necessary coordination between local governments and organizations to assist with domestic violence prevention and responses to fatalities; and
- Make a recommendation in its 2022 annual written report whether and how diversity, equity, and inclusion training could be provided for individuals who provide initial call response functions and for local boards who may conduct a fatality review to create greater trust between local agencies and victims of domestic violence.

The review board is set to repeal on September 1, 2022. The bill extends the repeal to September 1, 2027 and requires a sunset review prior to the repeal. The bill also repeals the review board's associated cash fund.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-31-702, **add** (8),  
 3 (9), (10), (11), (12), and (13) as follows:

4 **24-31-702. Colorado domestic violence fatality review board**  
 5 **- creation - membership - purpose - duties.** (8) THE REVIEW BOARD  
 6 SHALL PROVIDE TECHNICAL ASSISTANCE AND TRAINING TO LOCAL  
 7 GOVERNMENTS AS NEEDED TO HELP ESTABLISH AND MAINTAIN A REVIEW  
 8 TEAM AND SHALL PROVIDE TECHNICAL ASSISTANCE AND TRAINING TO  
 9 EXISTING REVIEW TEAMS AS NEEDED.

10 (9) THE REVIEW BOARD SHALL PURSUE IMPLEMENTATION OF ANY  
 11 REVIEW BOARD RECOMMENDATIONS PERTAINING, BUT NOT LIMITED TO:

12 (a) IMPROVING COMMUNICATION AND INFORMATION-SHARING  
 13 BETWEEN PUBLIC AND PRIVATE ORGANIZATIONS AND AGENCIES AS TO  
 14 DOMESTIC VIOLENCE INCIDENTS AND RISK;

15 (b) REDUCING THE INCIDENCE OF DOMESTIC VIOLENCE AND  
 16 DOMESTIC VIOLENCE FATALITIES IN THE STATE; AND

17 (c) IMPROVING RESPONSES TO DOMESTIC VIOLENCE INCIDENTS.

1 (10) THE REVIEW BOARD SHALL PROVIDE ANY NECESSARY  
2 COORDINATION BETWEEN LOCAL GOVERNMENTS AND ORGANIZATIONS TO  
3 ASSIST WITH DOMESTIC VIOLENCE PREVENTION AND RESPONSES TO  
4 FATALITIES.

5 (11) THE REVIEW BOARD SHALL MAKE A RECOMMENDATION IN ITS  
6 2022 ANNUAL WRITTEN REPORT WHETHER AND HOW DIVERSITY, EQUITY,  
7 AND INCLUSION TRAINING COULD BE PROVIDED FOR INDIVIDUALS WHO  
8 PROVIDE INITIAL CALL RESPONSE FUNCTIONS AND COULD BE PROVIDED FOR  
9 LOCAL BOARDS WHO MAY CONDUCT A FATALITY REVIEW TO CREATE  
10 GREATER TRUST BETWEEN LOCAL AGENCIES AND VICTIMS OF DOMESTIC  
11 VIOLENCE.

12 (12) (a) THE REVIEW BOARD SHALL COORDINATE WITH  
13 STAKEHOLDERS TO DEVELOP BEST PRACTICES FOR COLLECTING DATA ON  
14 DOMESTIC VIOLENCE-RELATED FATALITIES.

15 (b) THE REVIEW BOARD AND LOCAL REVIEW TEAMS SHALL  
16 COORDINATE TO IMPLEMENT EFFECTIVE INFORMATION-SHARING RELATED  
17 TO IDENTIFIED DOMESTIC VIOLENCE FATALITIES.

18 (13) (a) THE REVIEW BOARD SHALL PERFORM OUTREACH TO LOCAL  
19 GOVERNMENTS AND ORGANIZATIONS TO PROMOTE THE DEVELOPMENT OF  
20 LOCAL REVIEW TEAMS.

21 (b) THE REVIEW BOARD SHALL PRIORITIZE DEVELOPMENT AND  
22 SUPPORT OF LOCAL REVIEW TEAMS IN UNDERSERVED AND RURAL  
23 COMMUNITIES.

24 **SECTION 2.** In Colorado Revised Statutes, **amend** 24-31-706 as  
25 follows:

26 **24-31-706. Repeal of part.** This part 7 is repealed, effective  
27 ~~September 1, 2022~~ SEPTEMBER 1, 2027. PRIOR TO THE REPEAL OF THIS

1 PART 7, THE DOMESTIC VIOLENCE FATALITY REVIEW BOARD MUST BE  
2 REVIEWED AS PROVIDED FOR IN SECTION 2-3-1203.

3 **SECTION 3.** In Colorado Revised Statutes, **repeal** 24-31-705 as  
4 follows:

5 **24-31-705. Colorado domestic violence fatality review board**  
6 **contracts - grants - cash fund created.** ~~(1) To fulfill its duties under~~  
7 ~~this part 7 and subject to available money in the fund created in~~  
8 ~~subsection (1)(c) of this section, the department and the review board~~  
9 ~~may:~~

10 ~~(a) Hire staff and contract with consultants with expertise in~~  
11 ~~domestic violence fatality review;~~

12 ~~(b) Contract with local entities;~~

13 ~~(c) Expend money from the fund to pay the direct and indirect~~  
14 ~~costs of implementing this part 7;~~

15 ~~(d) Expend money from the fund to reimburse local review teams~~  
16 ~~for the direct and indirect costs of implementing this part 7;~~

17 ~~(e) Seek, accept, and expend gifts, grants, and donations from~~

6 **SECTION 4.** In Colorado Revised Statutes, 2-3-1203, add  
7 (18)(a)(II) as follows:

8 **2-3-1203. Sunset review of advisory committees - legislative**  
9 **declaration - definition - repeal.** (18) (a) The following statutory  
10 authorizations for the designated advisory committees will repeal on July  
11 1, 2027:

12 (II) THE DOMESTIC VIOLENCE FATALITY REVIEW BOARD CREATED  
13 IN SECTION 24-31-702.

14 **SECTION 5.** In Colorado Revised Statutes, 24-31-701, **repeal** (2)  
15 as follows:

16 **24-31-701. Definitions.** As used in this part 7, unless the context  
17 requires otherwise:

18 (2) "Fund" means the Colorado domestic violence fatality review  
19 board cash fund created in section 24-31-705.

20 **SECTION 6. Safety clause.** The general assembly hereby finds,  
21 determines, and declares that this act is necessary for the immediate  
22 preservation of the public peace, health, or safety.
