A BILL FOR AN ACT CONCERNING REPEALING THE REQUIREMENT THAT THE FEDERAL GOVERNMENT CONFIRM CERTAIN PERSONS' STATUSES BEFORE ISSUANCE OF AN IDENTIFICATION DOCUMENT, AND, IN

104 CONNECTION THEREWITH, MAKING AN APPROPRIATION.

Bill Summary

Under existing law, the department of revenue (department) is required to issue a driver's license, instruction permit, or identification card (identification documents) to a person who is lawfully present in the SENATE 3rd Reading Unamended April 28, 2022

Amended 2nd Reading 3rd Re April 27, 2022 A United States if:

- The individual qualifies for the identification document;
- The individual produces documents that satisfy the department that the individual is lawfully present; and
- The federal government confirms the individual's status, including electronically through the federal systematic alien verification for entitlements (SAVE) system.

The bill repeals the requirement that the federal government confirm the individual's status.

1	Be it enacted by the General Assembly of the State of Colorado:
2	SECTION 1. In Colorado Revised Statutes, amend 42-2-506 as
3	follows:
4	42-2-506. Identification documents - individuals temporarily
5	lawfully present. (1) An individual who is temporarily present in the
6	United States may apply for an identification document under PURSUANT
7	TO this section. The department shall issue an identification document if
8	THE INDIVIDUAL:
9	(a) The individual:
10	(I) (a) Qualifies for the document applied for except for
11	qualifications that conflict with this section; and
12	(II) (b) Produces documents that satisfy the department that the
13	individual is lawfully present in the United States. and
14	(b) The federal government confirms the individual's status,
15	including electronically through the SAVE system.
16	SECTION 2. Appropriation. (1) For the 2022-23 state fiscal
17	year, \$19,397 is appropriated to the department of revenue. This
18	appropriation is from the Colorado DRIVES vehicle services account in
19	the highway users tax fund created in section 42-1-211 (2)(b)(I), C.R.S.
20	To implement this act, the department may use this appropriation as

2	(a) \$15,300 for DRIVES maintenance and support;
3	(b) \$2,575 for the purchase of information technology services;
4	<u>and</u>
5	(c) \$1,522 for use by the executive director's office for personal
6	services.
7	(2) For the 2022-23 state fiscal year, \$2,575 is appropriated to the
8	office of the governor for use by the office of information technology.
9	This appropriation is from reappropriated funds received from the
10	department of revenue under subsection (1)(b) of this section. To
11	implement this act, the office may use this appropriation to provide
12	information technology services for the department of revenue.
13	SECTION 3. Safety clause. The general assembly hereby finds,
14	determines, and declares that this act is necessary for the immediate
15	preservation of the public peace, health, or safety.
