The 30 majority leader in each house shall direct that a memo be prepared on the date of the asterisked final passage deadline that lists all of the bills 31 32 to which this exclusion applies. A copy of the memo shall be attached to each bill listed in the memo and a copy shall be sent to each of the bill's 33 34 sponsors. At the discretion of the respective majority leaders, the list may 35 include any bills that have been referred out of the Appropriations 36 Committee during the seven legislative days preceding the asterisked final passage deadline.
