**A BILL FOR AN ACT**

101      **CONCERNING CLARIFICATION OF THE SCOPE OF THE AUTHORITY OF**  
102              **THE DIVISION OF HOUSING TO SPEND MONEY FOR CERTAIN TYPES**  
103              **OF GRANTS.**

**Bill Summary**

**Sections 1 and 4** of the bill clarify that money that was transferred from the general fund or the affordable housing and home ownership cash fund to the Colorado heritage communities fund on June 27, 2021, or as soon as was practicable thereafter, must be expended before July 1, 2025.

**Section 2** clarifies that money that was transferred from the

general fund to the housing development grant fund on June 27, 2021, must be expended before July 1, 2025.

**Section 3** clarifies that the division of housing may award multiple grants to multiple grant recipients for multiple regional navigation campuses in the Denver metropolitan area to respond to and prevent homelessness.

**Section 5** makes a conforming amendment.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-32-130, **amend**  
3 (7) as follows:

4 **24-32-130. Local government affordable housing development**  
5 **incentives grant program - local government planning grant program**  
6 **- creation - report - definitions.** (7) All funding of any grants awarded  
7 under either the housing development incentives grant program or the  
8 planning grant program must be made entirely out of the money  
9 transferred from the general fund and the affordable housing and home  
10 ownership cash fund created in section 24-75-229 (3)(a), that originates  
11 from money the state received from the federal coronavirus state fiscal  
12 recovery fund, to the Colorado heritage communities fund created in  
13 section 24-32-3207 (1) in accordance with section 24-32-3207 (6). All  
14 costs incurred by the division in administering either the housing  
15 development incentives grant program or the planning grant program  
16 must be paid out of the money transferred under section 24-32-3207 (6).  
17 The division may use up to four percent of any money transferred to it  
18 under this section to cover its administrative costs in administering or  
19 evaluating either the housing development incentives grant program or  
20 the planning grant program. All money transferred into the Colorado  
21 heritage communities fund in accordance with section 24-32-3207 (6)  
22 must be expended ~~by July 1, 2024~~ BEFORE JULY 1, 2025. Any money

1 transferred into the fund in accordance with this subsection (7) that is not  
2 expended or encumbered from any appropriation at the end of any fiscal  
3 year is available for expenditure ~~by July 1, 2024~~ BEFORE JULY 1, 2025,  
4 without further appropriation.

5 **SECTION 2.** In Colorado Revised Statutes, 24-32-721.7, **amend**  
6 (1)(b) as follows:

7 **24-32-721.7. Affordable housing guided toolkit and local**  
8 **officials guide program - creation.** (1)(b) All funding of any assistance  
9 awarded under the housing toolkit program must be made entirely out of  
10 the money transferred from the general fund to the housing development  
11 grant fund created in section 24-32-721 (1) in accordance with section  
12 24-32-721 (6). All costs incurred by the division in administering the  
13 housing toolkit program must be paid out of the money transferred in  
14 accordance with section 24-32-721 (6). The division may use up to eight  
15 percent of any money appropriated to it under this section to cover its  
16 administrative costs in administering the housing toolkit program. All  
17 money transferred to the housing development grant fund in accordance  
18 with section 24-32-721 (6) must be expended ~~over the subsequent three~~  
19 ~~state fiscal years~~ BEFORE JULY 1, 2025. ANY SUCH MONEY THAT IS NOT  
20 EXPENDED OR ENCUMBERED FROM ANY APPROPRIATION AT THE END OF  
21 ANY FISCAL YEAR IS AVAILABLE FOR EXPENDITURE BEFORE JULY 1, 2025,  
22 WITHOUT FURTHER APPROPRIATION.

23 **SECTION 3.** In Colorado Revised Statutes, 24-32-727, **amend**  
24 (2), (3) introductory portion, (4), (5), (6), (7), (8)(a), and (8)(d) as  
25 follows:

26 **24-32-727. Denver-metropolitan regional navigation campuses**  
27 **grant - regional navigation campuses cash fund - creation -**

1 **definitions.** (2) A local government or local governments applying  
2 together or a community partner in conjunction with one or more local  
3 governments may submit an application for a grant to the division in  
4 accordance with policies, procedures, and guidelines adopted by the  
5 division in order to build or acquire, and then facilitate, ~~a~~ ONE OR MORE  
6 regional navigation ~~campus~~ CAMPUSES in the Denver metropolitan area  
7 to respond to and prevent homelessness. The division, in collaboration  
8 with the department of human services and the behavioral health  
9 administration in the department of human services, shall establish the  
10 application requirements, which must include a plan by which ~~the~~ AN  
11 applicant intends to sustain funding FOR the regional navigation campus  
12 OR CAMPUSES after the grant period ends.

13 (3) Each applicant shall demonstrate how the applicant plans to  
14 build or acquire, and then facilitate, ~~a~~ ONE OR MORE navigation ~~campus~~  
15 CAMPUSES that may include, but ~~is~~ ARE not limited to, the following:

16 (4) In selecting ~~a~~ grant ~~recipient~~ RECIPIENTS, the division, in  
17 collaboration with the department of human services and the behavioral  
18 health administration in the department of human services, shall consider:

19 (a) An applicant's commitment to regional and transformational  
20 projects that ~~addresses~~ ADDRESS homelessness;

21 (b) An applicant's commitment to providing wraparound services  
22 for the residents at ~~the~~ EACH supportive residential campus;

23 (c) The impact of ~~the~~ EACH proposed navigation campus in the  
24 community where it will be located and in the Denver-metropolitan  
25 region as a whole; and

26 (d) The ability of the applicant to manage ~~the~~ EACH location and  
27 determine long-term operational costs and sustainability.

1 (5) In adopting policies, procedures, and guidelines, the division  
2 shall collaborate with the department of human services and the  
3 behavioral health administration in the department of human services to  
4 create a process that ensures ~~the grant is~~ THAT GRANTS ARE only awarded  
5 after a fair and rigorous open competition among eligible applicants. The  
6 division shall review applications and select ~~the grant recipient~~  
7 RECIPIENTS in collaboration with partnering agencies.

8 (6) The division, A grant recipient, or any other person who  
9 receives money from the division pursuant to this section shall comply  
10 with the compliance, reporting, record-keeping, and program evaluation  
11 requirements established by the office of state planning and budgeting  
12 and the state controller in accordance with section 24-75-226 (5).

13 (7) On July 1, 2022, the state treasurer shall transfer fifty million  
14 dollars from the economic recovery and relief cash fund, created in  
15 section 24-75-228, that originates from the money the state received from  
16 the federal coronavirus state fiscal recovery fund, to the regional  
17 navigation ~~campus~~ CAMPUSES cash fund for the purposes of this section.  
18 The division may expend up to ten percent of the money appropriated or  
19 transferred to the fund to pay for its direct and indirect costs in  
20 administering ~~the grant~~ GRANTS. All administrative costs must be paid out  
21 of the money transferred to the fund pursuant to this subsection (7).

22 (8) (a) The regional navigation ~~campus~~ CAMPUSES cash fund,  
23 referred to in this section as the "fund", is created in the state treasury.  
24 The fund consists of money transferred to the fund pursuant to subsection  
25 (7) of this section and any other money that the general assembly may  
26 appropriate or transfer to the fund.

27 (d) ~~The~~ A grant recipient must expend or obligate any money

1 received pursuant to this section in accordance with section 24-75-226  
2 (4)(d).

3 **SECTION 4.** In Colorado Revised Statutes, 24-32-3207, **amend**  
4 (6)(d) as follows:

5 **24-32-3207. Colorado heritage communities fund - creation -**  
6 **source of funds.** (6) (d) The division of local government in the  
7 department shall use the money transferred pursuant to subsection (6)(c)  
8 of this section for the creation, implementation, and administration of the  
9 local government planning grant program created in section 24-32-130  
10 (5) in accordance with the requirements of section 24-32-130. With  
11 respect to any money transferred into the Colorado heritage communities  
12 fund pursuant to subsection (6)(c) of this section, the division may use  
13 any money that is unexpended or unencumbered as of ~~June 30, 2024~~ JUNE  
14 30, 2023, for purposes of the local government affordable housing  
15 development incentives grant program created in section 24-32-130 (2)  
16 as needed in accordance with section 24-32-130.

17 **SECTION 5.** In Colorado Revised Statutes, 24-75-402, **amend**  
18 (5)(vv) as follows:

19 **24-75-402. Cash funds - limit on uncommitted reserves -**  
20 **reduction in the amount of fees - exclusions - definitions.**

21 (5) Notwithstanding any provision of this section to the contrary, the  
22 following cash funds are excluded from the limitations specified in this  
23 section:

24 (vv) The regional navigation ~~campus~~ **CAMPUSES** cash fund created  
25 in section 24-32-727;

26 **SECTION 6. Safety clause.** The general assembly hereby finds,

- 1 determines, and declares that this act is necessary for the immediate
- 2 preservation of the public peace, health, or safety.
