A BILL FOR AN ACT

101 **CONCERNING WATER QUALITY IN MOBILE HOME PARKS, AND, IN**
102 **CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill creates a water testing program for mobile home parks (parks). The testing program is developed and administered by the water quality control division (division) in the department of public health and environment (department). The bill also sets testing prioritization criteria and testing standards. If the testing reveals a water quality issue, the division will notify the following and include information about the test

results, recommended actions, remediation, and the grant program established in the bill:

- The park owner;
- The county department of health or municipality where the park is located;
- The water supplier; and
- The environmental justice ombudsperson (ombudsperson).

Upon receiving the notice, the park owner must:

- Notify the park residents;
- Comply with orders of the division;
- Not impose the cost of compliance on park residents;
- Within 90 days after receiving the notice, prepare and submit to the division a remediation plan;
- Complete the remediation plan based on a schedule approved by the division; and
- Consult with the division and provide an alternative water supply or department-approved filters.

The division will coordinate with the division of housing in the department of local affairs to identify potential money, including grant money from the grant program created in the bill, to support park water quality remediation.

The division will develop an action plan to address and improve water quality in parks. Standards are established for the action plan, including environmental justice principles, and the development of the action plan.

The bill creates a grant program to help park owners and local governments address water quality issues. The division will implement and administer the grant program. The general assembly will annually appropriate money to the department to fund the grant program.

The bill is enforced by the division, which may issue cease-and-desist orders.

A violation of the bill is a violation of the "Colorado Consumer Protection Act", and the bill further establishes that:

- If a park owner fails to develop a remediation plan or implement the remediation plan, the park will be declared a class 3 public nuisance, and the park owner must forfeit the park;
- A park owner that fails to register under the "Mobile Home Park Act Dispute Resolution and Enforcement Program" violates the "Colorado Consumer Protection Act"; and
- A person may bring a civil action under the "Mobile Home Park Act".

A park that has been forfeited because it is a class 3 public nuisance becomes the property of the county where the park is located, and the county will continue to operate the park to provide affordable

housing for no fewer than 100 years. Penalties imposed under the "Colorado Consumer Protection Act" are deposited in a fund to be used to provide grants through the grant program and for the division to administer and enforce the bill.

The ombudsperson is given the duty to represent park residents in matters of water quality.

The bill adds water quality issues to the database created by the "Mobile Home Park Act Dispute Resolution and Enforcement Program", which tracks complaints filed against parks.

2 **SECTION 1.** In Colorado Revised Statutes, **add** part 10 to article

6 **25-8-1001. Definitions.** AS USED IN THIS PART 10, UNLESS THE
7 CONTEXT OTHERWISE REQUIRES:

8 (1) "ACTION PLAN" MEANS THE STATEWIDE ACTION PLAN CREATED
9 BY THE DIVISION IN ACCORDANCE WITH SECTION 25-8-1004.

10 (2) "COLORADO ENVIROSCREEN" MEANS THE ENVIRONMENTAL
11 JUSTICE MAPPING TOOL DEVELOPED AND ADMINISTERED BY THE
12 DEPARTMENT AND COLORADO STATE UNIVERSITY, OR ANY SUCCESSOR
13 TOOL.

14 (3) "DEPARTMENT" MEANS THE STATE DEPARTMENT OF PUBLIC
15 HEALTH AND ENVIRONMENT.

16 (4) "DIVISION" MEANS THE WATER QUALITY CONTROL DIVISION IN
17 THE DEPARTMENT.

18 (5) "DIVISION OF HOUSING" MEANS THE DIVISION OF HOUSING IN
19 THE DEPARTMENT OF LOCAL AFFAIRS.

1 (6) (a) "FINISHED WATER" MEANS WATER THAT IS SUPPLIED TO A
2 DISTRIBUTION SYSTEM OF A MOBILE HOME PARK AND INTENDED FOR
3 DISTRIBUTION AND HUMAN CONSUMPTION.

4 (b) "FINISHED WATER" INCLUDES DRINKING WATER PRESENT
5 ANYWHERE IN THE DISTRIBUTION SYSTEM.

6 (7) "FUND" MEANS THE MOBILE HOME PARK WATER QUALITY FUND
7 CREATED IN SECTION 25-8-1006.

8 (8) "GRANT PROGRAM" MEANS THE MOBILE HOME WATER QUALITY
9 GRANT PROGRAM CREATED IN SECTION 25-8-1005.

10 (9) "LOCAL GOVERNMENT" MEANS:

18 (11) "PARK OWNER" MEANS EACH PERSON THAT OWNS A MOBILE
19 HOME PARK, ACTING INDIVIDUALLY OR JOINTLY, AND THE AGENT OF THE
20 PARK OWNER WITH RESPECT TO MATTERS CONCERNING THE PARK.

21 (12) "OMBUDSPERSON" MEANS THE ENVIRONMENTAL JUSTICE
22 OMBUDSPERSON APPOINTED UNDER SECTION 25-1-134 OR THE
23 OMBUDSPERSON'S DESIGNEE.

24 (13) "REMEDIATION" MEANS THE RESOLUTION OF ALL WATER
25 QUALITY ISSUES OF A FINISHED WATER SOURCE, SO THAT THE FINISHED
26 WATER IS SAFE AND HEALTHY TO DRINK. "REMEDIATE" HAS A
27 CORRESPONDING MEANING.

(14) "TESTING PROGRAM" MEANS THE PROGRAM TO TEST MOBILE HOME PARK WATER QUALITY CREATED IN ACCORDANCE WITH SECTION 25-8-1002 (1)(a).

(15) "WATER QUALITY ISSUE" MEANS, WITH REGARD TO FINISHED WATER OR WATER SUPPLY, THAT:

(a) THE FINISHED WATER FAILS TO COMPLY WITH THE PRIMARY DRINKING WATER QUALITY STANDARDS ESTABLISHED BY RULE UNDER SECTIONS 25-8-202 AND 25-8-204, OR WITH ANY MAXIMUM CONTAMINANT LEVEL ESTABLISHED BY THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY; OR

(b) THE DIVISION HAS MADE A WRITTEN DETERMINATION THAT THE FINISHED WATER OR WATER SUPPLY IS OF SUFFICIENTLY LOW QUALITY TO PRESENT A RISK TO THE WELFARE, HEALTH, OR SAFETY OF INDIVIDUALS WHO CONSUME THE WATER.

(16) "WATER SUPPLY" MEANS THE SUPPLY OF A SOURCE OF FINISHED WATER TO A PARK'S RESIDENTS. "WATER SUPPLY" INCLUDES PRIMARY SOURCE WATER, WELLS, RIVERS, WATER SYSTEMS, AND WATER PURCHASED FROM ANOTHER WATER SYSTEM.

25-8-1002. Division duties - testing water quality at mobile home parks - parameters of testing - notice of results. (1) Testing program. (a) BY JULY 1, 2024, THE DIVISION SHALL DEVELOP AND BEGIN CONDUCTING A PROGRAM TO TEST THE QUALITY OF FINISHED WATER AT MOBILE HOME PARKS. THE TESTING PROGRAM IS IN ADDITION TO ANY OTHER TESTING PERFORMED PURSUANT TO THIS ARTICLE 8. THE DIVISION MAY CONTRACT WITH THIRD-PARTY ENTITIES TO PERFORM THE TESTING.

(b) THE DIVISION SHALL ENSURE THAT MATERIALS, INFORMATION,

1 AND COMMUNICATIONS SHARED WITH MEMBERS OF THE PUBLIC RELATED
2 TO THE TESTING PROGRAM ARE AVAILABLE IN BOTH ENGLISH, SPANISH,
3 AND ANY OTHER LANGUAGE REQUESTED BY A RESIDENT OR THAT THE
4 DIVISION DETERMINES IS NECESSARY TO PROVIDE REASONABLE NOTICE.

5 (c) THE DIVISION SHALL TEST, IN ACCORDANCE WITH THIS SECTION,
6 FINISHED WATER AT:

7 (I) TWENTY-FIVE PERCENT OF THE TOTAL NUMBER OF PARKS BY
8 JULY 1, 2025;

9 (II) FIFTY PERCENT OF THE TOTAL NUMBER OF PARKS BY JULY 1,
10 2026;

11 (III) SEVENTY-FIVE PERCENT OF THE TOTAL NUMBER OF PARKS BY
12 JULY 1, 2027; AND

13 (IV) ONE HUNDRED PERCENT OF THE TOTAL NUMBER OF PARKS BY
14 JULY 1, 2028.

15 (d) (I) THE DIVISION SHALL BEGIN TESTING BY SAMPLING THE
16 FINISHED WATER AND THE WATER SUPPLY AT PARKS THAT REPRESENT
17 GEOGRAPHICALLY DIVERSE LOCATIONS ACROSS COLORADO, BOTH IN
18 URBAN AND RURAL LOCATIONS, BASED ON THE FOLLOWING
19 PRIORITIZATION CRITERIA, NOT LISTED IN ORDER OF IMPORTANCE:

20 (A) PARKS LOCATED IN A CENSUS BLOCK GROUP WHERE AT LEAST
21 FORTY PERCENT OF RESIDENTS IDENTIFY AS A RACIAL OR ETHNIC
22 MINORITY;

23 (B) PARKS IN A GEOGRAPHIC AREA THAT IS KNOWN TO PRODUCE
24 CONTAMINANTS IN FINISHED WATER BECAUSE OF THE GEOLOGY OF THE
25 GEOGRAPHIC AREA;

26 (C) PARKS AT A HIGHER RISK OF EXPERIENCING CUMULATIVE
27 EFFECTS ON WATER QUALITY BECAUSE THEY ARE LOCATED IN THE MOST

1 RECENT VERSION OF ITS CENSUS BLOCK GROUP WITH A COLORADO
2 ENVIROSCREEN SCORE ABOVE THE EIGHTIETH PERCENTILE;

3 (D) PARKS WHERE RESIDENTS HAVE REQUESTED TESTING;

4 (E) PARKS WHERE RESIDENTS HAVE SUBMITTED COMPLAINTS,
5 INCLUDING CONSIDERATION OF THE LARGEST NUMBER OF COMPLAINTS,
6 ABOUT THE QUALITY OF THE FINISHED WATER TO THE DEPARTMENT, TO
7 THE DIVISION OF HOUSING, OR TO THE OMBUDSPERSON; █

8 (F) PARKS THAT ARE SUPPLIED WITH FINISHED WATER FROM AN
9 UNREGULATED WATER SUPPLY; AND

10 (G) PARKS THE DIVISION DETERMINES SHOULD BE PRIORITIZED.

11 (II) THE DIVISION SHALL CREATE A WAITING LIST IF REQUESTS FOR
12 FINISHED WATER TESTING AT PARKS EXCEED THE DIVISION'S CAPACITY FOR
13 CONDUCTING THE TESTING WITHIN THIRTY DAYS AFTER THE REQUEST.

14 █ (2) **Testing parameters.** (a) IN DEVELOPING THE TESTING
15 PROGRAM, THE DIVISION SHALL INTERVIEW RESIDENTS OF PARKS TO
16 UNDERSTAND RESIDENT EXPERIENCES, INCLUDING DAMAGE TO
17 APPLIANCES, HEALTH EFFECTS, AND ECONOMIC EFFECTS, AND SHALL
18 ASSESS POSSIBLE CAUSES OF CONCERN ABOUT THE QUALITY OF FINISHED
19 WATER, INCLUDING CONCERNS ABOUT FINISHED WATER THAT HAS AN
20 ABNORMAL COLOR, ODOR, OR TASTE. THE DIVISION SHALL CONDUCT THE
21 INTERVIEWS IN ENGLISH, SPANISH, OR ANY OTHER LANGUAGE REQUESTED
22 BY A RESIDENT OR THAT THE DIVISION DETERMINES IS NECESSARY TO
23 CONDUCT THE INTERVIEW.

24 (b) IN DEVELOPING THE TESTING PROGRAM, THE DIVISION SHALL
25 DETERMINE AND APPROVE A SPECIFIC SAMPLING AND TESTING PLAN FOR
26 EACH PARK REQUIRING ANY WATER QUALITY TESTING THAT THE DIVISION
27 DETERMINES IS NECESSARY TO ASSESS THE FINISHED WATER'S SAFETY AND

1 QUALITY AND TO ASSESS PARK RESIDENT CONCERNS IDENTIFIED IN THE
2 INTERVIEWS DESCRIBED IN SUBSECTION (2)(a) OF THIS SECTION. THE
3 TESTING MAY INCLUDE:

4 (I) TESTING TO DETERMINE IF THE WATER COMPLIES WITH THE
5 PRIMARY AND SECONDARY DRINKING WATER STANDARDS ESTABLISHED BY
6 RULE UNDER SECTIONS 25-8-202 AND 25-8-204 AND WITH THE MAXIMUM
7 CONTAMINANT LEVELS OR SECONDARY MAXIMUM CONTAMINANT LEVELS
8 ESTABLISHED BY THE UNITED STATES ENVIRONMENTAL PROTECTION
9 AGENCY;

10 (II) TESTING TO EVALUATE HARDNESS, IRON, CALCIUM, AND TOTAL
11 DISSOLVED SOLIDS; AND

12 (III) TESTING FOR CHEMICALS WITH HEALTH ADVISORY LEVELS IF
13 THE DIVISION BELIEVES THE CHEMICALS MAY BE PRESENT IN THE FINISHED
14 WATER.

15 (c) EACH APPROVED SAMPLING AND TESTING PLAN IS SUBJECT TO
16 REVIEW AND REVISION BY THE DEPARTMENT.

17 (d) THE DIVISION IS AUTHORIZED TO NOT TEST FINISHED WATER AT
18 A PARK FOR A SPECIFIC CONTAMINANT IF INFORMATION EXISTS SHOWING
19 THE CONTAMINANT IS NOT NEAR OR IN EXCESS OF THE STANDARD IN THE
20 FINISHED WATER OR IF TESTING OF THE CONTAMINANT IS ALREADY
21 REQUIRED BY A PARK'S REGISTRATION AS A PUBLIC WATER SYSTEM.

22 (e) THE DIVISION SHALL REQUIRE THAT ANY SAMPLING AND
23 ANALYSIS PERFORMED IN THE FIELD FOR THE TESTING PROGRAM IS
24 CONDUCTED BY A QUALIFIED PROFESSIONAL, AS DETERMINED BY THE
25 DIVISION.

26 (f) IN IMPLEMENTING THE TESTING PROGRAM, THE DIVISION SHALL:

27 (I) USE THE SAMPLE HOLD TIMES FOR VALID SAMPLING IN

1 ACCORDANCE WITH THE RULES PROMULGATED UNDER SECTIONS 25-8-202
2 AND 25-8-204; AND

3 (II) AVOID TESTING WITHIN A MOBILE HOME WITHOUT THE
4 OWNER'S OR RENTER'S CONSENT AND EVALUATE POSSIBLE ALTERNATE
5 TESTING LOCATIONS, INCLUDING PEDESTALS AND SERVICE LINES.

6 (3) **Notice of test results.** (a) TEST RESULTS OBTAINED IN
7 ACCORDANCE WITH THIS SECTION ARE PUBLIC RECORDS. THE DIVISION
8 SHALL MAKE THE TEST RESULTS ACCESSIBLE AS SOON AS POSSIBLE ON A
9 PUBLIC WEBSITE ON WHICH THE TEST RESULTS MAY BE VIEWED IN
10 ENGLISH, SPANISH, AND ANY OTHER LANGUAGE REQUESTED BY A
11 RESIDENT OR THAT THE DIVISION DETERMINES IS NECESSARY TO PROVIDE
12 REASONABLE NOTICE.

13 (b)(I) WITHIN TEN DAYS AFTER RECEIVING THE TEST RESULTS, THE
14 DIVISION SHALL NOTIFY THE FOLLOWING PERSONS OF THE TEST RESULTS
15 OBTAINED IN ACCORDANCE WITH THIS SECTION FOR EACH PARK:

- 16 (A) THE PARK OWNER;
- 17 (B) THE COUNTY DEPARTMENT OF HEALTH WHERE THE PARK IS
18 LOCATED;
- 19 (C) THE MUNICIPALITY, IF ANY, WHERE THE PARK IS LOCATED;
- 20 (D) THE DIVISION OF HOUSING IN THE DEPARTMENT OF LOCAL
21 AFFAIRS;
- 22 (E) THE WATER SUPPLIER; AND
- 23 (F) THE OMBUDSPERSON.

24 (II) IF TEST RESULTS SHOW THAT A PARK'S FINISHED WATER HAS A
25 WATER QUALITY ISSUE, THE DIVISION'S NOTIFICATION DESCRIBED IN
26 SUBSECTION (3)(b)(I) OF THIS SECTION MUST INCLUDE:

- 27 (A) A SUMMARY OF THE TEST RESULTS AND INFORMATION

1 CONCERNING THE AVAILABILITY OF THE COMPLETE TEST RESULTS;

2 (B) INFORMATION ABOUT ANY VIOLATION OF WATER QUALITY
3 STANDARDS FOR FINISHED WATER;

4 (C) GUIDANCE ABOUT ANY ACTIONS RESIDENTS SHOULD TAKE IN
5 LIGHT OF ANY VIOLATIONS OF WATER QUALITY STANDARDS FOR FINISHED
6 WATER;

7 (D) GUIDANCE ABOUT THE REMEDIATION PROCESS, AS DESCRIBED
8 IN SECTION 25-8-1003; AND

9 (E) INFORMATION ABOUT THE GRANT PROGRAM.

10 (c) (I) UPON RECEIVING NOTICE OF TEST RESULTS IN ACCORDANCE
11 WITH SUBSECTION (3)(b)(I)(A) OF THIS SECTION, THE PARK OWNER SHALL
12 NOTIFY THE PARK RESIDENTS OF THE TEST RESULTS WITHIN FIVE DAYS IN
13 ENGLISH, SPANISH, AND ANY OTHER LANGUAGE REQUESTED BY A
14 RESIDENT OR THAT THE DIVISION DETERMINES IS NECESSARY TO PROVIDE
15 REASONABLE NOTICE AND INCLUDE IN THE NOTICE THE INFORMATION AND
16 GUIDANCE RECEIVED FROM THE DIVISION IN ACCORDANCE WITH
17 SUBSECTION (3)(b)(II) OF THIS SECTION. THE PARK OWNER SHALL USE A
18 PROFESSIONAL TRANSLATOR TO PROVIDE THE NOTICE IN ANY LANGUAGE
19 OTHER THAN ENGLISH. AFTER GIVING THE NOTICE, THE PARK OWNER
20 SHALL CERTIFY TO THE DIVISION THAT THE PARK OWNER HAS NOTIFIED
21 THE RESIDENTS.

22 (II) IN ADDITION TO DIRECTLY NOTIFYING RESIDENTS, A PARK
23 OWNER SHALL ALSO POST THE NOTICE OF TEST RESULTS IN ENGLISH,
24 SPANISH, AND ANY OTHER LANGUAGE REQUESTED BY A RESIDENT OR THAT
25 THE DIVISION DETERMINES IS NECESSARY TO PROVIDE REASONABLE
26 NOTICE IN A CLEARLY VISIBLE LOCATION IN PARK COMMON AREAS,
27 INCLUDING ANY COMMUNITY HALL OR RECREATION HALL. THE NOTICE

1 MUST:

2 (A) REMAIN CLEARLY VISIBLE IN THE COMMON AREA FOR AT LEAST
3 ONE HUNDRED TWENTY DAYS AFTER THE DATE IT IS POSTED; AND

4 (B) USE A TRANSLATION PROVIDED BY A PROFESSIONAL
5 TRANSLATOR.

6 (III) IF A PARK OWNER FAILS TO PROVIDE AND POST THE NOTICE
7 REQUIRED BY SUBSECTIONS (3)(c)(I) AND (3)(c)(II) OF THIS SECTION TO
8 RESIDENTS WITHIN FIVE BUSINESS DAYS AFTER RECEIPT OF THE NOTICE
9 FROM THE DIVISION, THE PARK OWNER IS SUBJECT TO SECTION 38-12-1104
10 AND PART 2 OF ARTICLE 12 OF TITLE 38.

11 **25-8-1003. Remediation.** (1) IF TESTING CONDUCTED IN
12 ACCORDANCE WITH THE TESTING PROGRAM IDENTIFIES A WATER QUALITY
13 ISSUE IN FINISHED WATER, THE DIVISION SHALL:

14 (a) PERFORM OR REQUIRE ADDITIONAL TESTING, IF NECESSARY, OF
15 THE FINISHED WATER OR WATER SUPPLY AT THE PARK, AND THIS TESTING
16 MAY INCLUDE CONTINUED TESTING, TESTING OF MULTIPLE POINTS IN THE
17 WATER SUPPLY OUTSIDE THE MOBILE HOME, AND TESTING OF FLOW RATES
18 AND OF WATER PRESSURE;

19 (b) NOTIFY THE DIVISION OF HOUSING AND THE PERSONS LISTED IN
20 SECTION 25-8-1002 (3)(b)(I);

21 (c) TIMELY REVIEW THE REMEDIATION PLAN DESCRIBED IN
22 SUBSECTION (2)(c) OF THIS SECTION, AND EITHER:

23 (I) APPROVE THE PLAN; OR

24 (II) DENY THE PLAN WITH A WRITTEN EXPLANATION OF THE
25 REASON THE PLAN WAS DENIED AND MAKE RECOMMENDATIONS FOR
26 ADDRESSING THE REASON THE PLAN WAS DENIED; AND

27 (d) WHEN THE WATER QUALITY ISSUE HAS BEEN REMEDIATED,

1 NOTIFY THE DIVISION OF HOUSING.

2 (2) UPON RECEIVING THE NOTICE MADE UNDER SUBSECTION (1)(b)

3 OF THIS SECTION, THE PARK OWNER SHALL:

4 (a) COMPLY WITH ANY ORDERS OF THE DIVISION RELATED TO THE

5 WATER QUALITY ISSUE;

6 (b) NOT IMPOSE THE COST OF COMPLIANCE WITH THIS SUBSECTION

7 (2) ON PARK RESIDENTS;

8 (c) WITHIN ONE HUNDRED TWENTY DAYS AFTER RECEIVING THE

9 NOTICE, PREPARE AND SUBMIT TO THE DIVISION A REMEDIATION PLAN,

5 QUALITY ISSUE AT A PARK.

16 UNDER THIS SECTION AND SHALL PRIORITIZE FUNDING FOR APPLICATIONS

19 (II) THE NUMBER OF PEOPLE AFFECTED BY THE WATER QUALITY

2 SECTION 10. In Colorado Revised Statutes, 38-12-220, amend
3 (1) as follows:

4 38-12-220. Private civil right of action. (1) A home owner, a
5 resident, an association of home owners, or a landlord or the assignee of
6 a home owner, a resident, an association of home owners, or a landlord
7 may file a civil action alleging a violation of a rental agreement or of any
8 provision of this article 12 OR PART 10 OF ARTICLE 8 OF TITLE 25.

10 (2) A RETALIATORY ACTION DESCRIBED IN SUBSECTION (1) OF THIS
11 SECTION IS REBUTTABLY PRESUMED TO BE RETALIATION IN VIOLATION OF
12 THIS SECTION IF DONE WITHIN ONE HUNDRED TWENTY DAYS AFTER THE
13 TENANT DOES AN ACTION DESCRIBED IN SUBSECTION (1)(a) TO (1)(c) OF
14 THIS SECTION.

15 SECTION 11. In Colorado Revised Statutes, 38-12-1106, amend
16 (7)(e); and add (7)(g) as follows:

17 38-12-1106. Registration of mobile home parks - process - fees.
18 (7) The registration forms provided by the division must require
19 information necessary to assist the division in identifying and locating a
20 mobile home park and other information that may be useful to the state.
21 A registration is not complete unless the landlord includes all of the
22 information required by the forms provided by the division. The forms
23 must require, at a minimum:

24 (e) The physical address of each mobile home within the mobile
25 home park and the mailing address of the home owner, if the landlord has
26 a different mailing address on file for the home owner; and

1 (f) A DESCRIPTION OF THE MOBILE HOME PARK'S WATER SOURCE,
2 INCLUDING THE TYPE OF WATER SOURCE; AND

3 (g) THE METHOD FOR CHARGING RESIDENTS FOR WATER AND
4 SEWER, WHETHER WATER AND SEWER CHARGES ARE INCLUDED IN RENT,
5 SUBMETERED, OR BY OTHER COLLECTION MEANS.

6 **SECTION 12.** In Colorado Revised Statutes, 38-12-1108, **amend**
7 (1), (2)(c), and (2)(d); and **add** (2)(e) as follows:

8 **38-12-1108. Mobile home park complaint and water issue**
9 **database.** (1) ~~By May 1, 2020,~~ The division shall also create and
10 maintain a database of mobile home parks that have had complaints filed
11 against them under the program OR THAT HAVE AN UNREMIEDIATED WATER
12 QUALITY ISSUE AS DETERMINED PURSUANT TO PART 10 OF ARTICLE 8 OF
13 TITLE 25.

14 (2) At a minimum, the database must include:

15 (c) The violation of law complained of; ~~and~~

16 (d) The outcome of each complaint; AND

17 (e) WHETHER THE MOBILE HOME PARK HAS A WATER QUALITY
18 ISSUE, AS DESCRIBED IN THE NOTICE FROM THE WATER QUALITY CONTROL
19 DIVISION IN ACCORDANCE WITH SECTION 25-8-1003 (1)(b), THAT HAS NOT
20 BEEN REMEDIATED.

21 **SECTION 13. Appropriation.** (1) For the 2023-24 state fiscal
22 year, \$3,611,859 is appropriated to the mobile home park water quality
23 fund created in section 25-8-1006 (1), C.R.S. This appropriation is from
24 the general fund. The department of public health and environment is
25 responsible for the accounting related to this program.

26 (2) For the 2023-24 state fiscal year, \$3,407,448 is appropriated
27 to the department of public health and environment. This appropriation

1 is from reappropriated funds in the mobile home park water quality fund
2 under subsection (1) of this section. To implement this act, the
3 department may use the appropriation for as follows:

4 (a) \$1,065,779 for use by the water quality control division for
5 administration, which amount is based on an assumption that the division
6 will require an additional 10.8 FTE;

7 (b) \$2,303,603 for use by the water quality control division for
8 personal services related to the drinking water program; and

9 (c) \$38,066 for the purchase of legal services.

10 (3) For the 2023-24 state fiscal year, \$38,066 is appropriated to
11 the department of law. This appropriation is from reappropriated funds
12 received from the department of public health and environment under
13 subsection (2) of this section and is based on an assumption that the
14 department of law will require an additional 0.2 FTE. To implement this
15 act, the department of law may use this appropriation to provide legal
16 services for the department of public health and environment.

17 (4) For the 2023-24 state fiscal year, \$136,885 is appropriated to
18 the mobile home park act dispute resolution and enforcement program
19 fund created in section 38-12-1110 (1), C.R.S. This appropriation is from
20 the general fund. The department of local affairs is responsible for the
21 accounting related to this program.

22 **SECTION 14. Applicability.** This act applies to offenses
23 committed or conduct occurring on or after the effective date of this act.

24 **SECTION 15. Safety clause.** The general assembly hereby finds,
25 determines, and declares that this act is necessary for the immediate
26 preservation of the public peace, health, or safety.
