Capital Development Committee. Current law requires a state agency or institution of higher education that receives an appropriation for a capital construction project to allocate not less than one percent of the state funded portion of the project for the acquisition of works of art. In the 2022-23 fiscal year, the general assembly appropriated money from

the revenue loss restoration cash fund to state agencies and institutions of higher education for capital construction projects. The bill clarifies that the state funded portion of a capital construction project includes money appropriated from the revenue loss restoration cash fund.

In addition, for appropriations for capital construction projects made for the 2022-23 fiscal year only, the bill makes the allocation for the acquisition of works of art discretionary rather than mandatory and allows a state agency or institution of higher education that opts not to make such an allocation to use the money that would otherwise be used for works of art for any other costs associated with the capital construction project.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-48.5-312, **amend**
3 (3)(a)(I)(A); and **add** (3)(a)(IV) as follows:

9 ASSOCIATED WITH THE CAPITAL CONSTRUCTION PROJECT.

10 **SECTION 2. Safety clause.** The general assembly hereby finds,
11 determines, and declares that this act is necessary for the immediate
12 preservation of the public peace, health, or safety.
