**Joint Budget Committee.** The bill increases the amounts of transfers from the general fund to the capital construction fund and from the general fund to the information technology capital account of the capital construction fund that are scheduled to be made on July 1, 2023, as follows:

- The transfer from the general fund to the capital construction fund is increased by \$14,607,257, from \$233,361,030 to \$247,968,287; and
- The transfer from the general fund to the information technology capital account of the capital construction fund is increased by \$3,605,507, from \$60,308,481 to \$63,913,988.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-75-302, **amend**  
 3 **as added by Senate Bill 23-243** (2)(ss) and (2.3)(o) as follows:

4 **24-75-302. Capital construction fund - capital assessment fees**  
 5 **- calculation - information technology capital account.** (2) The  
 6 controller shall transfer a sum as specified in this subsection (2) from the  
 7 general fund to the capital construction fund as money becomes available  
 8 in the general fund during the fiscal year beginning on July 1 of the fiscal  
 9 year in which the transfer is made or on the date otherwise specified for  
 10 the transfer. Transfers between funds pursuant to this subsection (2) are  
 11 not appropriations subject to the limitations of section 24-75-201.1. The  
 12 amounts transferred pursuant to this subsection (2) are as follows:

13 (ss) On July 1, 2023, two hundred ~~thirty-three million three~~  
 14 ~~hundred sixty-one thousand thirty~~ FORTY-SEVEN MILLION NINE HUNDRED  
 15 SIXTY-EIGHT THOUSAND TWO HUNDRED EIGHTY-SEVEN dollars;

16 (2.3) In addition to the sums transferred pursuant to subsections  
 17 (2) and (2.5) of this section, the state treasurer and the controller shall  
 18 transfer a sum as specified in this subsection (2.3) from the general fund  
 19 to the information technology capital account created in subsection (3.7)  
 20 of this section as money becomes available in the general fund during the  
 21 fiscal year beginning on July 1 of the fiscal year in which the transfer is  
 22 made or on April 1 of the fiscal year if otherwise specified. Transfers

1 between funds pursuant to this subsection (2.3) are not appropriations  
2 subject to the limitations of section 24-75-201.1. The amounts transferred  
3 pursuant to this subsection (2.3) are as follows:

4 (o) On July 1, 2023, ~~sixty million three hundred eight thousand~~  
5 ~~four hundred eighty-one~~ SIXTY-THREE MILLION NINE HUNDRED THIRTEEN  
6 THOUSAND NINE HUNDRED EIGHTY-EIGHT dollars;

7 **SECTION 2. Safety clause.** The general assembly hereby finds,  
8 determines, and declares that this act is necessary for the immediate  
9 preservation of the public peace, health, or safety.
