The House Appropriations Committee Report (03/10/23), adopted on second reading (03/11/23), added an appropriation clause that is consistent with the Revised Fiscal Note. The Senate Education Committee Report (03/20/23) also includes amendments to the bill. Legislative Council Staff and JBC Staff agree that none of those amendments change the fiscal impact of the bill.

Current Appropriations Clause in Bill

The bill includes an appropriation clause that appropriates \$33,260 General Fund to the Department of Education for FY 2023-24.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2023-24 based on the March 2023 Office of State Planning and Budgeting (OSP) revenue forecast. The budget package includes two set-asides for legislation outside of the package: (1) \$30.0 million General Fund for bills that create ongoing obligations; and (2) \$469.0 million for bills that create one-time obligations for FY 2023-24 (see table below).

The budget package accounts for the 15.0 percent reserve associated with the above placeholders (a total of \$74.9 million).

This bill creates an ongoing obligation and requires a General Fund appropriation of \$33,260 for FY 2023-24, reducing the \$30.0 million set aside by the same amount.
