Summary of Legislation

The bill authorizes two state institutions of higher education to complete energy-related capital construction projects, and transfers funds from the Severance Tax Operational Fund for this purpose.

State Transfers

On July 1, 2023, the bill transfers \$10,000,000 from the Severance Tax Operational Fund to the Capital Construction Fund.

State Expenditures

The bill increases state expenditures by \$10 million in FY 2023-24 through FY 2025-26 in the Department of Higher Education. While expenditures are shown in Table 1 as occurring in FY 2023-24, actual expenditures will depend on the timing of project implementation.

Colorado Mesa University. The bill dedicates \$6 million to expand the campus-wide geothermal-exchange system to all buildings on the main campus at Colorado Mesa University.

Western Colorado University. The bill dedicates \$4 million to provide additional teaching and laboratory space for the petroleum geology program at Western Colorado University, and to generally allow for the expansion of the Natural and Environmental Sciences Department.

Technical Note

Appropriations included in the capital construction portion of the Long Bill have spending authority for three fiscal years. The fiscal note assumes that the appropriations in this bill also require three-year spending authority.

Effective Date

The bill takes effect upon signature of the Governor, or upon becoming law without his signature.

State Appropriations

For FY 2023-24, the bill includes appropriations of \$10,000,000 from the Capital Construction Fund to the Department of Higher Education for the following purposes:

- \$6,000,000 for use by Colorado Mesa University; and
- \$4,000,000 for use by Western Colorado University.
