1 *Be It Resolved by the Senate of the Seventy-fourth General*  
2 *Assembly of the State of Colorado, the House of Representatives*  
3 *concurring herein:*

4 That in the Joint Rules of the Senate and House of  
5 Representatives, Joint Rule No. 23, **amend** (a)(1) as follows:

6 **23. DEADLINE SCHEDULE**

7 (a) (1) ***Deadline schedule.*** For the purposes of organizing the  
8 legislative session, the schedule for the enactment of  
9 legislation shall be as follows:

*Capital letters or bold & italic numbers indicate new material to be added to existing law.*  
*Dashes through the words or numbers indicate deletions from existing law.*

25 *that have been referred out of the Appropriations Committee during the*  
26 *seven legislative days preceding the asterisked final passage deadline. In*  
27 *addition, bills in the Appropriations Committee in either house on the day*  
28 *of a separate final passage deadline as specified by the Committee on*  
29 *Delayed Bills for that house are also excluded from the specified final*  
30 *passage deadline unless otherwise indicated in the delayed bill form.*
