Current Appropriations Clause in Bill

The bill requires but does not contain an appropriation clause.

Description of Amendments in This Packet

J.001 Staff has prepared amendment **J.001** (attached) to add a provision appropriating \$98,073 General Fund to the Department of Health Care Policy and Financing for FY 2024-25. This provision also states that the appropriation is based on the assumption that the Department will require an additional 0.8 FTE.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSP) revenue forecast. The budget package includes \$93.5 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$14.0 million).

This bill requires a General Fund appropriation of \$98,703 for FY 2024-25, reducing the \$93.5 million set aside by the same amount.

Future Fiscal Impact

The cost to implement the bill increases from \$98,703 General Fund in FY 2024-25 to roughly \$3.3 million total funds, including \$1.4 million General Fund, in FY 2025-26 and approximately \$3.9 million total funds, including \$1.2 million General Fund, in FY 2026-27 and thereafter.
