Impact of Emergency Rental Assistance Two



54 counties have been

served by Emergency Rental Assistance Two

99.6% of all Colorado renters

reside in the these counties

97% of funds spent



Temporary Rental Assistance Grant: Eligibility Requirements



Be at 80% Area Median Income (AMI) or below

Be at risk of eviction or displacement.

Be applying for support for their primary residence.

Have a notice of late rent from their landlord.

Have not received rental assistance within the past 12 months.

Attest to some other risk factor(s) that caused them to fall behind, such as:

- A healthcare event, including mental health;
- A loss or decrease in income;
- A death in the family;
- A need to leave your home due to domestic abuse; and/or
- A substantial, unexpected expense, such as a car repair.




Special Session Implementation: House Bill 23B-1001 Rental Assistance



\$30 million in Temporary Rental Assistance Grant

Will help approximately **3,700 Colorado households** that are past-due on rent stay in their homes.

- Request for Applications published on **November 29, 2023**
- Request for Applications Closed December 18, 2023
- Five nonprofits selected **December 29, 2023**
- Funds must be expended by June 30, 2024
- First round of pre-applications February 15th-20th
- Next round March 15-20th



Temporary Rental Assistance Grant: Distribution of Funds



Rental assistance must be reviewed, approved, and distributed through Colorado nonprofit organizations.



- CEDP
- La Puente
- Total Concept
- Neighbor to Neighbor
- Brothers Redevelopment











Program Design: Distribution of Funds



Based on estimates nonprofit partners shared, we can review and approve approximately **3,700** households during this program.

With current average award sizes of \$7k (with prospective rent) with ERA, that should **expend available funds**, but depends on meeting these estimates.







Proposition 123: Homeownership Achievements



Fiscal Year 2023-2024 Achievements: \$32 Million

Acquisition and Development (New Construction and Rehabilitation)	Awarded \$6.8 million for 152 units. Reviewing applications for \$8 million that would add 178 units	
Owner Repair	Awarded one application for an entity to manage \$895,000 in single family owner-occupied rehab funds	
Down Payment Assistance	Awarded three programs over \$7 million to support 180 homeownership opportunities. Underwriting two applications for \$2.4 million	

Proposition 123: Homeownership Funds Remaining




Funds remaining for homeownership

The division is on track to award or expend more than \$32 million by June 2024.

The remaining funds include:

- Underwriting 7 applications for \$10 million to serve 263 households
- \$5.5 million of pipeline projects expected to submit applications between March and June

Proposition 123: Homelessness Achievements



Fiscal Year 2023-2024 Achievements: \$28.8 million

Development of Supportive Housing	Awarded three projects totaling \$12.175 million for 218 units	
Street Outreach	Awarded 17 applicants totaling \$1.02 million	
Rapid Rehousing	Awarded 25 applicants totaling \$1.14 million	
Homeless Prevention	Awarded 20 applicants totaling \$1.31 million	
Emergency Shelter	Awarded 56 applicants totaling \$4.53 million	
Supportive Services	NOFA released November 2023 for approximately \$2.5 million	

Proposition 123: Homelessness Funds Remaining




Funds Remaining for homelessness

The division is on track to award or expend more than \$28.8 million by June 2024.

The remaining funds include:

- \$4 million for Colorado Renters Stabilization Program (CRSP) NOFA being released in March 2024.
- \$2.68 million were included in November Request for Applications for the Creation of Supportive Housing, funding determinations in conjunction with CHFA's LIHTC annual cycle, with first round expected in May.



Proposition 123: Homelessness - Coming Up



Funding opportunities for fiscal year 2024 - 2025.

- Prevention and diversion
- Street outreach and inreach
- Emergency shelters and transitional housing
- Rapid re-housing and permanent supportive housing
- Systems improvement and capacity building

\$56.5 million allocated for homelessness programs

Technical assistance opportunities for fiscal year 2024 - 2025.

- Launch government commitment 2-year filings. (2024 was three years) Opens May
 2024
- 134 jurisdictions eligible for a 2-year
 commitment; deadline is November 1, 2024

Proposition 123: Local Planning Capacity Grant Achievements



Fiscal Year 2023-2024 Achievements: \$3 Million to Award

Local Planning Capacity
Grant Program

Awards of \$2.5 million to be announced in March 2024 for 26 projects, supporting 37 local governments.

Expedited Review of Affordable Housing

Fast Track of affordable housing through land use code changes, improving policies and procedures, and other strategies.

Guidance on Prop 123 Fast Track Requirement

Facilitation of **stakeholder engagement process** with developers, local governments and key partners to publish guidance on new requirements and recommend best practices and strategies.

Proposition 123: Local Planning Grant Funds Remaining




Funds Remaining for Local Planning

The Division is on track to award **86**% of this year's available funding, or **\$ 2.6 million**.

The remaining funds roll forward to next FY:

- \$424,002 rolled over, due to applicants withdrawing applications.
- Next round of funding opens May 2025
- \$6 million available to award
